Parents Guidance Notes

- **Parents are requested to complete the attached form if they are thinking about any supplementary provision for their child from September 2022. This is a provisional request to assist with school staffing arrangements and a confirmation of provision required will be requested in our Information Pack, provided to parents once your child has been offered a Nursery place.**
- Full 30 hour provision is available on the site of St Andrew's C of E VC Primary School. Applications for the afternoon provision on a Monday, Wednesday and Friday at Bobtails Playgroup must be made directly to the other provider.
- In accordance with our published admissions criteria, the school will allocate places for the 15 hours universal free childcare provision (mornings - Monday – Friday), in the first instance. Any requested afternoon provision will then be arranged for the 30 allocated applicants.
- ** Any applicants who are applying for Option 10 only, (ie afternoon provision only) would be expected to take up their initial 15 hour universal free childcare with another provider. These applications will be considered after the initial allocation of 30 Nursery places has been completed.
- * Additional Government funded provision for the lunch club and afternoon sessions as part of the '30 hour provision' is offered free of charge to parents who are eligible or chargeable for parents who are ineligible. *(Please see 30 hour Provision – am I eligible? for further information)*
- A '30 hour free childcare' Voucher Code must be provided to confirm eligibility *(see term & conditions attached)*
- As the '30 hour' funding requires that the provision for 6 hours per day is 'seamless', parents will have the opportunity to purchase further 'top up' childcare cover with either on site provider to cover their child's care until 3.15pm on the appropriate days.
- The above will be applicable if parents take up the full 30 hours provision. If not, the additional 'top up' will not need to be paid for separately, but can be taken from parent's allocation of 30 hours across the week.
- Where applicable, additional fees will be charged at the current Government rate *(£5.24 p/hr from 1.4.21 – 31.3.22)*
- We have an electronic payment system called Wisepay where chargeable sessions can be paid for or alternatively we are registered to accept various Childcare Vouchers.
